

Volunteer Requirements

Memorandum & Information Sheet from the Archdiocese of Portland

St. Cecilia, along with every other school and church within the Archdiocese of Portland, follows requirements referred to as Called to Protect. These requirements are set forth by the Archdiocese to ensure that our volunteers and staff are trained and cleared to work in schools, and that our schools and churches remain safe for our kids. Please remember, **EVERYONE** has a new requirement **EVERY** school year. Please plan ahead and complete your requirements so that you are able to participate when opportunities arise.

RETURNING VOLUNTEERS:

You have 2 requirements that must be completed this school year. In addition, you must have a current background check on file and have completed the Standards of Conduct (this online module available by following instructions below). You must be up to date before you will be permitted to volunteer.

Complete the *Prevention of Sexual Harrassment and Duty to Report*. This is done online using the instructions below.

2. Enter your user name and password.

NEW VOLUNTEERS:

You have 3 additional requirements that are necessary before you will be permitted to volunteer.

1. Complete a Criminal Background Check. Email Mrs. McIntyre that you need a background check with the following information: Legal First and Last Name, Birthdate and Birth Month and a valid email address.

2. Attend a Called to Protect Training. This presentation is available at a number of scheduled times. See the attached document from the Archdiocese, please RSVP to the class of your choice and bring a copy of your completion certificate to the front office.

3. Complete the **Complete the *Prevention of Sexual Harrassment and Duty to Report*. This is done online using the instructions below.** NOTE: Your log-in will not be active until you have completed the background check.

4. Choose the module entitled **Standards of Conduct**. Read the document and electronically sign the form.
Please note - you do not need to complete the other modules that are visible upon login.

During the Called to Protect training, you will watch **TWO** videos - ***Called to Protect for Parents and Families*** and ***Called to Protect for Ministries***. Per Archdiocesan guidelines, as long as you remain current with your background check and yearly online training courses, **you are only required to watch the DVD series one time.**
